**The TWU Negotiating Committees reconvened in Dallas, Texas the week of April 7<sup>th</sup> to April 11<sup>th</sup>. During the week, members of the TWU M&R Negotiating Committee met with AA management. Below are each of the specific Negotiating Committee progress reports for the week.**

**In order to keep our members better informed, our new website went online Wednesday at 3:30 p.m. Cards mailed to members home have an error on the address. The correct address is listed above. On the website you can log on and register to get instant negotiation updates.**

**This week the Union responded to the Company's Article 13 (Seniority Lists) and Article 46 (One Station Agreements) proposals. The Company accepted the Union's last proposal on Article 27 (General) and Article 43 (Part-Time Employees) these articles were TA'd. The Company also passed a counter proposal for Article 13 (Seniority Lists), Article 7 (Holiday). The Union continued going through the Company's Art 11 and 12 re-write. The Union and the Company are currently at an impasse on Articles 17 (Leaves of Absence), 23 (Attendance at Hearings, Investigations or Training Classes), 25 (Recall and Call in Work), 26 (Field Trips), 39 (Physical Examination).**
